



## SANDWELL CRICKET LEAGUE

### UMPIRES' REPORT FORM – INCIDENT IN SANDWELL CRICKET LEAGUE MATCH

The completed report must be with the League Secretary within 14 days of the alleged incident, and is subject to the Discipline, Complaints & Appeals Procedure outlined in the League Handbook. Please try to include as much factual evidence as possible including names, times, actions, positions, words used, gestures or threats made, physical actions etc.
